Chair Rick sent out an email at 2:07pm on Oct 24, 2024, to all attending members mentioned above, which included all trustees. He provided a PDF attachment listing medical supplies required to ensure the medical staff at the station can respond to calls involving a medical requirement. He attached a PDF of an online order for the supplies needed; estimated cost of supplies \$2000.00 including shipping.

Treasurer Ellen Eskildsen responded at 2:27pm with her approval of the purchase of the critical need for

medical supplies for the station and made a motion to approve the purchase. She also wanted to inquire as to the whereabouts of the many medical supplies that were just purchased in the previous two months. Chair Grady then replied at 2:33pm to second the motion and agreed with Secretary Ellen's comments. Interim Chief Gilliam responded at 3:41pm saying that the medical supplies will allow the station to be at minimum requirements for their medical supplies and he will try to get restocked through St. Peters Hospital in the future but if they can't, he will keep the board informed of anything they may need ahead of time. Chair Grady responded at 3:45pm stating that the emails will be added to the minutes for conducting the emergency meeting.

Trustee Max Eskildsen responded at 7:03pm stating he agreed to the purchase of the required medical items; he voted yes to purchase. He stated that the board is still awaiting an itemized list of medical supplies purchased the last two months.

Chair Grady responded at 7:26pm stating that the feedback to purchase the medical supplies will proceed as Max, Ellen and himself responded via email to approve the purchase. He received no responses from Vice chair Jim Thomas or Treasurer Wendy Adamson through their individual emails. The time to respond was 7:00pm this evening of Thursday, Oct 24, 2024. He stated that Interim Chief Gilliam can now proceed working with Max and Ellen to purchase the requested medical supplies and the payment to be made on the personal credit card of Max Eskildsen to be reimbursed by the trustee board. Secretary Ellen will put together minutes with the emails sent and all pics presented as public record. No response from Treasurer Wendy Adamson or Vice Chair Jim Thomas.

Chair Grady adjourned the quorum Emergency Meeting at 7:26 pm.

Hello Ellen,

If this helps I have got the numbers for the last 3 months for you that where medical calls. I have also broken it down. I know in the past Birdseye medical calls; they would use their medical supplies on most of their calls. As for Marysville they do not have any medical supplies or medical staff and so both Canyon Creek and Birdseye would go back in forth depending on who was on scene first. As for our district I would hope we are using our supplies, but the call volume is not that great to be going through that may supplies and, in the past, we were able to restock our supplies with St Peters Ambulance after the call. We still do some of this at the Ski Hill, so I do not see that has changed much with restocking with St. Peters Ambulance. I can see some of the medical supplies expiring but we should not be ordering that many supplies to have on hand. What I went through was too much order in the past and they expired due to not going on enough medical calls. The medical supplies I am requesting is to just get us back up to minimum requirements. Then any medical supplies we use we will restock through St. Peters if we can. If not, I will track what we cannot get from St. Peters and update the Board at each month's trustee meeting. This way we are not spending large amounts of money on medical supplies.

Canyon Creek medical calls

- August 2 calls
- September 1 call
- October 0 calls

Birdseye medical calls

- August 5 calls
- September -- 11 calls
- October 3 calls

Marysville medical calls

- August 0 call
- September -- 0 call
- October 1 call

Total medical calls for all 3 districts for the last 3 months are 23. Canyon Creek had 3 calls in district, Birdseye had 19 calls and Marysville had 1 call.
